# Bob Rusbatch - EMC Coordinator for Middle Paxton Township/Dauphin Borough

- Mayor McKenna stated that the extreme winds on Friday, April 30 downed trees and wires in Middle Paxton Township, but no damage was reported in Dauphin Borough.

#### Jeff Thrush - Parks and Recreation

- Councilman Thrush said that the Central Dauphin Softball game was taking place that night and that Farm Show milkshakes would be available.

# **Engineer's Report**

- Engineer Heigel stated that the Park Project review showed six shrubs that appear to be dead or dying and the Borough is requesting that the contractor replace them before the project can be closed.
- There are long term needs to maintain the two bridges on Allegheny Street. Light-Heigel will look for future funding opportunities. A plan and a budget are being created.
- KCI Engineering is replacing Mr. Blinebury's current engineer. KCI stated revised plans were being prepared, however no plans were received. Engineer Heigel stated that the Borough should grant a 90 day extension or vote to deny. A motion to grant the 90 day extension was made by Vice President Cuddy, seconded by Councilman Bechtel and passed unanimously.
- The Annual Chapter 94 Report has been deemed acceptable by DEP.
- The next DCNR grant rounds are due next April for the Park Phase II project.

# Solicitor's Report

- The Peters Mountain Road property's April 30, 2021 settlement went smoothly.
- Regarding 608 Erie Street, Solicitor Zei told the executor that the Borough is moving forward with a tax sale.
- The Municipal Authority of the Borough of Dauphin will hold a meeting on June 8, 2021 at 6:00 pm.

- Junior Council Person Long is beginning a cap collection drive in order to receive more benches and perhaps picnic tables. The collection requires 1,050 pounds.
- Junior Council Person Long stated that the Trex bench from a previous drive is expected to arrive in approximately 10 weeks.
