I (We) have read and understand the Borough of Dauphin Fireworks Ordinance, Chapter 2020-06 of the Code of Ordinances, and agree to comply with all its terms and provisions, subject to the penalties set forth therein.

Further, I (we) hereby agree that the permit obtained by this Application is non-transferrable and that in the event of a change to any of the information provided on this Application, I (we) agree to notify the Borough within forty-eight (48) hours of such changes.
